#### Mergers and Acquisitions Continued

Represented client in three hotel acquisitions over a period of 10 consecutive weeks at a total deal amount of \$16 million. One transaction required negotiating complex estate-related issues with the seller. #### Finance and Investment Funds

Project included drafting end-to-end documents to establish a U.S. sub-distributor network, including sales agreements, product warranties, and other sub-distributor- and customer-facing documentation.

#### International Supply Chain

Structured \$25-million international private equity fund for a Mexican family, focused on nearshoring to Mexico and reshoring to the U.S. The fund included related entities in the U.S., Europe, and Brazil to accommodate investors for tax efficiency purposes.
